MARKET BEEF

Division B
 July 19 @ Sales Arena

1. Judging will be held on Tuesday, July 17 in the Show Arena immediately followed by the showmanship contest. Market Dairy Beef will show on Wednesday, July 18 following the Dairy Feeder Show.

2. All Market Beef must be owned by December 1st and identified by the Livestock committee on December 15, 2012.

3. All Market beef must have been born after Jan. 1, 2012 and recommended to be 425 – 850 pounds at weigh-in on December 8, 2012. Market Dairy Beef must be born after Nov 1, 2011.

4. Market Beef are to be in place by 7:00 AM, July 16 and will be assigned to the proper weight classes following the weigh-in on Monday, July 16, at 8:00 AM. Animals are not to be “shrunk” for this weigh-in. Market Beef are not to be fed or watered after 9:00 PM on Tuesday, July 17 until after they are re-weighed on Wednesday, July 18 @ 7:30 AM.

5. All market beef must weigh at least 1000 pounds to show in the Junior Fair Market Beef contest. Market Dairy Beef must weigh at least 1100 pounds to show and sell.

6. All breeds will show together, with the exception of market dairy beef. Market dairy beef may be purebred or crosses of only dairy breeds. Beef/Dairy crosses will show in the beef show. There will be a maximum of 10 market beef in each class.

7. Exhibitors may show a maximum of 2 market beef in the regular Junior Fair market beef Show.

8. All Market beef will be entered in the Rate of Gain Contest.

9. All market beef must be dehorned, castrated, and healed by weigh-in on December 8, 2012.

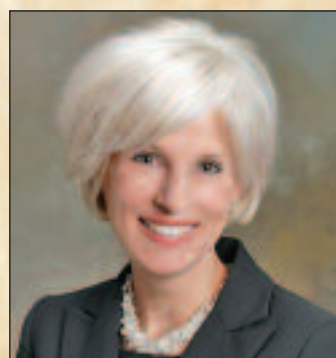

4-H Project Book 201S (Showmanship)

– Each member may enter one dog per class. Any individual dog may be shown in only one showmanship class, providing the dog is 6 months of age or older. The dog and member may show in either Showmanship A or B depending on the age and experience level of the exhibitor. Each dog will be inspected for proper care and grooming. In addition, the 4-H member will be evaluated on dog care knowledge which is taken from the Dog Resource Handbook (Covers the basics of showmanship)

4-H project book 201O (Dog Obedience)

– Each member may enter one dog per class. All dogs must be 6 months of age or older. Any individual dog may be shown in only one obedience class. In addition the dog will be inspected for proper grooming. (Covers beginning and advanced obedience training and Rally)

4-H Project Book 201P (Performance)

– Exhibitors showing in Obedience or Showmanship may also show in Drill Team Competition, Agility, Brace and Team with 1 or 2 of the same 2 project dogs. Dogs shown in Brace must be the 4-H member's project dogs.

4-H Project Book 201W (Working Dogs)

– Include assistance dogs like Pilot Dogs, Canine Companions and other service dog organizations.

GUIDELINES

1. 4-H members must be enrolled in the correct project and level; 201S Showmanship, 201O Dog Obedience, ALL 4H members taking a Dog Project are required to take the Skillathon and must pass with an 85% or higher.

2. Dogs must be owned either by the 4-H member or a member of their immediate family no later than April 1, 2013. The dog must be in continual care of the 4-H member for the duration of the project.

3. For Dog Projects- Immediate family is defined as the 4-H members' father, mother, brother, sister, uncle, aunt, grandfather or grandmother, including step and half relations, or by a member of the exhibitor's household.

4. Continued care is defined as the 4-H member being responsible for and involved in the feeding, cleaning, and caring of the dog.

5. Lessons, instructions and advice for the 4-H member are encouraged. As long as the 4-H member is present in the learning situation, and handles or trains the dog the majority of the time present, such assistance can include occasional handling or training by another person. Only the 4-H member can train the dog at any type of training class on or after April 1, 2013. No one other than the 4-H member is permitted to show the 4H Project Dog at any type of dog show includ-

ing fun matches.

6. Criteria for participation:

a. All dogs are required to be vaccinated yearly for Distemper, Hepatitis, Letospirosis, Parainfluenza, Parvovirus and Rabies by a licensed, accredited veterinarian. 4-H members must have either an ODA Official Health Certificate or the Certificate of Vaccination for the 4H Dog Project. Other certificates of vaccinations, pet record cards or kennel records will not be accepted.

b. Make sure when getting the ODA Official Health Certificate or the Certificate of Vaccinations for the 4-H Dog Project, be certain the dates of the required vaccinations, including the rabies vaccinations are listed. Make certain it is signed by the veterinarian. The veterinarian must also provide their license number or their name/address stamp in the space provided.

c. All required vaccinations must have been given after August 16, 2012 and prior to July 16, 2013

d. All dogs participating in the Fayette County Junior Fair Dog Show must be currently licensed in the 4-H members' county of residence. The 4-H member must bring a certificate of license to registration.

e. Upon arrival to the Junior Fair Dog Show area all 4-H member will need to stop at the check in table. 4-H members will need to have the health certificate and dog license.

7. Dogs must be kept on a leash while on the fairgrounds, except when participating in the ring during judging. Dogs must be kenneled in designated areas. 4-H member is expected to clean up after their dogs.

8. Each dog must go through a check station where all females will be checked for signs of heat. If a female dog shows signs of heat the dog may be shown with the judges' permission. Decisions at the check-in station are final.

9. All 4-H members will provide their own equipment as needed, such as collar, leash, water dish, kennel etc.

10. The judge or Senior Superintendents may dismiss from the ring any dog exhibiting unsafe or threatening behaviors or any exhibitor abusing the dog.

11. Previous participants and or dogs in classes Beginner Novice (Sub-Novice A), Novice A, Open A and Graduate A may not enter the same class.

12. 4-H members showing their dogs at any licensed or Member Obedience Trail or at a Sanctioned Match must show their dogs at the same or higher B level classes than they are showing in AKC, UKC or other titling shows. Dogs completing their Companion Dog (CD) title prior to or anytime during the project year must show in the Graduate Novice Classes at the very minimum. Those completing their Companion

Dog Excellent title must show in Open, Graduate Open or Utility Classes. For Grooming and Handling Classes, dogs with AKC Junior Handling or like experience must show in the age appropriate B classes.

13. 4-H members only taking Dog Projects 201D You and Your Dog must participate in the Miscellaneous Judging to be held on Thursday, June 27 at the Mahan Building.

SHOW EQUIPMENT AND HANDLER'S & DOG'S APPEARANCE:

1. Obedience collars include well-fitting plain buckle or quick release collars, or slip collars of an appropriate single length of leather, fabric or chain with two rings, one on each end. Leashes may be of fabric or leather and should be 6 feet in length for sub-novice classes. For novice, graduate novice classes, open and graduate open classes, the leash need be only of sufficient length to provide adequate slack in the heel on leash exercise. Chain leashes are not acceptable. Grooming and Handling collars include a chain or fabric slip collar, or martingale-type show lead. Nothing should be hanging from the collars. Leashes may be of fabric, leather or show chain and long enough to allow for easy handling of the dog.

2. Handler's appearance should be neat, and well-groomed in appearance. They should wear clothing that is comfortable to handle in and appropriate for the dog show. Clothing should not distract, limit or hinder the judge's view of the dog. For Grooming and Handling Classes it is recommended that girls wear skirts, dresses, skorts, dress shorts or similar attire and boys wear dress shirts, ties, and dress slacks. For Obedience, Dog Care, Brace, Team, Rally Classes colored dress jeans and dress shorts are appropriate.

3. Dog's appearance should be clean, well brushed and in good physical condition appropriate for the dog's age. The coat should be free from mats and loose hair. Ears should be clean and free from hair in the ear canal. Eyes should be free from matter, and teeth should be free from tartar. Some staining on the teeth of older dogs in permissible. Toenails should be trimmed and hair between the pads should be trimmed to prevent matting and collecting dirt.

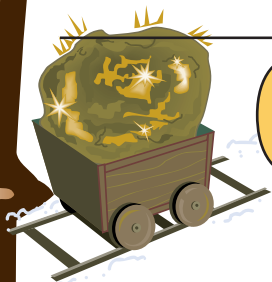

256C. Intermediate Showmanship A - Member must be 12-14 as of January 1. (The handler or dog has had no experience in Showmanship.)

256D. Intermediate Showmanship B. - Member must be 12-14 as of January 1, who have shown in Showmanship A or has prior experience in Showmanship, AKC Junior Handling or like experience.

256E. Junior Showmanship A - Member must be 9-11 as of January 1. (Neither handler nor dog with prior show experience in Showmanship.)

256F. Junior Showmanship B - Member must be 9-11 as of January 1, who have shown in Showmanship A or has prior experience in Showmanship, AKC Junior Handling or like experience.

OBEDIENCE:

257A. Open A-Neither the member nor the dog has any prior experiences at the open level. All exercise will be performed off leash. Exercises to be performed: heel free and figure 8, drop on recall, retrieve on flat, retrieve over high jump, broad jump, 3minute long sit, 5 minute long down (handler out of sight).

257B. Open B-Member or the dog has shown in Open A or has prior experiences at the Open level. All exercise will be performed off leash. Exercises to be performed: heel free and figure 8, drop on recall, retrieve on flat, retrieve over high jump, broad jump, 3 minute long sit, 5 minute long down (handler out of sight).

257C. Graduate Open A-Neither the member nor the dog has any prior experiences at the open graduate level. All exercise will be performed off leash. Exercises to be performed; signal exercise, scent discrimination, directed retrieve, moving stand and examination, go out, directed jump.

257D. Graduate Open B-Member or the dog has shown in Graduate Open A or has prior experiences at the Open level. All exercise will be performed off leash. Exercises to be performed; signal exercise, scent discrimination, directed retrieve, moving stand and examination, go out, directed jump.

258A. Graduate Novice A-Neither the member nor the dog has had any prior experiences at the graduate level. All exercise will be performed off leash except the heel exercise. Exercises to be performed: heel (on leash), and figure 8, drop on recall, dumbbell recall, recall over broad jump, recall over high jump, 3 minute long down (handler out of sight).

258B. Graduate Novice B-Member or the dog has shown in Graduate Novice A prior experiences at the graduate level. All exercise will be performed off leash except the heel exercise. Exercises to be performed: heel (on leash), and figure 8, drop on recall, dumbbell recall, recall over broad jump, recall over high jump, 3 minute long down (handler out of sight).

258C. Novice A-Member nor the dog has had any prior experience at the Novice level. Exercises to be performed: heel on leash, figure 8 on leash, stand for examination off leash, heel free, recall off leash, long sit (1 minute), long down (3 minutes).

258D. Novice B-Member or dog has shown in Novice A or has prior experiences in obedience. Exercises to be performed: heel on leash, figure 8 on leash stand for examination off leash, heel free, recall off leash, long sit (1 minute), long down (3 minutes).

258E. Beginner Novice A-(Formerly Sub Novice A) Neither the member nor the dog has had any prior obedience experience. Show one year then move to either Beginner Novice B or Pre-Novice. All exercises with be performed on leash. Exercises include; heel; figure 8, stand for examination, recall, long sit (1 minute) and long down (3 minute).

258F. Beginner Novice B-(Formerly Sub Novice B) Member or the dog has shown in Beginner Novice A-(Formerly Sub-Novice A) or has some prior experience in Obedience. Can move back and forth between Beginner Novice B and Pre-Novice until winning first place. All exercises with be performed on leash. Exercises include; heel; figure 8, stand for examination, recall, long sit (1 minute) and long down (3 minute).

258G. Pre-Novice neither the member nor the dog has had any prior obedience experience. Can show in Pre Novice until winning first place or experience at the Novice level. All exercises with be performed on leash. Exercises include; heel; figure 8, stand for examination, recall, long sit (1 minute) and long down (3 minute).

259A. Utility A- Member nor the dog has had any prior experience at the Utility Level. All exercises will be performed off leash. Exercises to perform; signal, scent discrimination, direct retrieve, moving stand and examination, directed jumping.

259B. Utility B-Member or the dog has had prior experience at the Utility Level A. All exercises will be performed off leash. Exercises to perform; signal, scent discrimination, direct retrieve, moving stand and examination, directed jumping.

260A. Rally Novice A-Member nor the dog has had any prior experience. All exercises will be performed on leash

260B. Rally Novice B-Member or dog has had prior experience showing in Rally Novice A. All exercise will be performed on leash.

260C. Rally Advanced A-member nor the dog has had prior experience at the Advanced level. All exercises will be performed off leash.

260D. Rally Advanced B-Member or dog has had prior experience at the Advance Level. All exercises will be performed off leash.

261. Working Dogs-This is for members enrolled in Dog project 201W. Exercises to be performed include; Accepting a friendly stranger, Sit polite for petting, Appearance and grooming, out for a walk, sit and down on command/staying in place, come when called, reaction to another dog, reaction to distraction, supervised separation.

Rules apply to both dairy and beef feeders.

1. All feeders must be owned and on feed by May 1, 2012

2. Feeders recommended to be born after Dec. 1, 2012. Exhibitors who have feeders born after Jan. 1, 2012 are given the option to sell or keep their feeder to take as a steer project the following year.

3. All feeders must be weighed, tagged, and vaccinated on May 1, 2012. Feeders must be dehorned and castrated before May 1, 2012. Castration means no testicular tissue and dehorned means no presence of horns/scurs. If testicular tissue and/or horns/scurs are present the animal will not be eligible for exhibit at the Fair.

4. Exhibitors may tag 4 and show 2 feeders.

5. Feeders must weigh between 300 and 750 pounds at Fair.

6. Dairy and Beef feeders will be shown separate and will be assigned to the proper weight classes following weigh-in. There will be a maximum of 10 feeders per class.

7. Feeders must be halter broke and easy to handle. Exhibitors must show in appropriate attire and animal must be shown with a halter. Feeders are to be shown like a beef steer.

8. Feeders must be in place by 7:00 AM on July 15 and will be weighed on July 15 at 8:00 AM. Beef Feeders will show on July 18 at 3:00 PM and Dairy Feeders will show on July 18 at 11:00 AM. Feeders that are going home may be released following the Sale Friday night between the hours of 11:00 PM and 7:00 AM Saturday.

9. Both Beef and Dairy feeders may be crossbred, but must be from recognized foundation breeds. No mix between dairy and beef breeds is permitted.

10. Feeder may be either heifers or castrated males.

1. Market and Breeding Goats must be in place by 7:00 AM on July 15. All dairy goats in production must be in place by 7:00 AM on July 16 and will be released following the show. Market goats, and breeding goats not in production, are released following the small animal sale.

2. Breeding goats must be purebred and recorded with their association; crossbred does may be non-registered purebred or crossbred animals. Registration/Entry of breeding stock must be provided if asked. Animals must be registered in the exhibitors or family name only. All breeding goats must have a USDA approved scrapie tag, or Tattoo, to be admitted to the fair. The USDA scrapie tag/tattoo will be the official fair identification.

3. Classes will be judged by breed. All recognized breeds may show. Classes will be divided by committee based on participation.

1. "Uniform Rules for 4-H Horse Shows in Ohio", 4-H circular 179 (Revised 2012), shall be the basis for judging.

2. All horses must be properly identified by an ID description sheet must be on file in the Extension Office by May 15, 2013.

3. A member's primary horse stays at the fair all week. Any member may bring a secondary horse for show day on Tuesday for driving or contest classes and taken home after the show. A secondary horse may be brought in on Friday for Fun Day. Any secondary horse must be one that is on an ID sheet on file by May 15, 2013. Standardbred project horses that are currently racing will be permitted to leave the fairgrounds to race at other locations during the week.

4. Stallions may be shown only in production classes and only within the same calendar year in which they were foaled. All foals must be haltered when shown. In the mare and foal class, the member with the production project shows the foal. Another 4-H horse member may assist by showing the mare. Production projects are brought in on Tuesday and taken home after their classes. Members taking production projects must be at least 13 years old as of January 1, 2013 and comply with requirements outlined in the "Uniform Rules" book (take project 185 and have a Production contract on file).

5. Ages of exhibitors on Jan. 1, 2013 this year shall determine the class in which exhibitors show.

6. All animals carried as 4-H projects must be owned or leased and in the continual care of the 4-H member by May 15, 2013. Continual care does permit boarding an animal provided the member is involved in caring for the horse and the horse is not a production animal. This rule is taken from the 2013 "Uniform Rules" book, pages 6 and 7. Boarding must be in Fayette County unless given permission by the Junior Fair Advisor. Completed boarding/training agreement papers must be on file in the Extension Office with the ID sheet by May 15, 2013. Completed lease papers must be on file in the Extension Office by May 15, 2013 for any horse that is leased. Project animals should not be switched during the year nor trained by other riders within 30 days prior to competing in 4-H classes. Members should con-

7. Only the exhibitor may ride the horse prior to the day of and during the horse show fair week or the PAS show with the exception for safety purposes. Approval must be given by the 4-H horse committee.

8. A negative Coggins test for EIA is not required for 4-H horses participating in any county fair event or the state fair horse show in 2013. Exception, Standardbred projects are subject to rules set by the harness racing authorities.

9. State Fair Selection: Members showing at the State Fair must have 1) qualified under the statewide "Performance Against Standards" (PAS) program and 2) complete their project according to Fayette County Junior Fair policies. There will be no PAS qualifying show in Fayette County in 2013. Members will have to participate in another county's show, provide proof of participation and qualifying scores from that county, and be entered in the state fair show through Fayette County's Extension office. Exhibitors will pay any entry fees for the qualifying show, and will be reimbursed by the horse committee when proof of participation is presented, if funds are available.

10. All exhibitors must complete a corresponding project book, and have that book checked and participate in the skillathon (if applicable) to exhibit at the fair.

11. All classes will be graded. Premiums will be paid to the 2 highest class placings for each exhibitor.

12. Exhibitors must follow all barn rules posted at the fair and those listed in the program handbook.

13. Participants in the Junior Fair horse activities must be enrolled in a current horse project or the Horseless Horse project. Cloverbud members are not permitted to participate in any horse competition.

7. All birds will need hatchery papers. This includes breeding, turkeys, and meat chickens.

8. No birds can enter the barn or be placed in their pen until they are checked in and hatchery papers are reviewed.

9. There will be no re-weighs after birds have already passed over official scale. Pens over the accepted 21 pounds will be classified as overweight. Birds may not be swapped out after they have already been weighed. If a bird dies or is injured, the member may not be provided another bird from home or by another member. Weigh-ins and check-ins are final, it is the member's responsibility to insure that the birds they bring meet their weight specifications at

weigh-ins and that they are well provided for during fair week.

10. Birds are expected to remain in the barn until Friday during the fair. The sale will still be on Wednesday evening, but birds must remain in the poultry barn until they are picked up on Friday. Members will be expected to continue to care for their birds until load-out time.

11. Hatch Dates are March 1st for turkeys and May 24th for chickens. Birds must be hatched on these dates or afterwards, not before.

12. Exhibitors may exhibit according to the following guidelines: (Note: This is by project, not years in 4-H, or age)

- Poultry I – exhibit 1–4 birds and/or Pen of 3.

- Poultry II – exhibit up to 6 single birds and/or Pen of 3.

- Poultry Advanced – exhibit up to 9 birds and/or Pen of 3.

- Meat Pen of Three

13. The American Poultry Association's Standard of Perfection will be the guide for judging all standard breed breeding stock.

14. Breeding stock will be divided into a minimum of five classes: Standard Bred Female, Standard Bred Male, Bantam Female, Bantam Male, and the Home Cross-bred Class. All breeding stock must be tested for pullorum/fowl typhoid by July 14, 2012 if older than one year of age.

15. The Standard and Bantam classes will be split into smaller classes if there are ten birds of any one category as outlined in the Standard of Perfection until the class is composed of a single breed unless it reduces the original class to less than ten birds.

16. First and second place will be awarded in all of the breeding classes and Overall Champion and Reserve male, and an Overall Champion and Reserve Female will be selected from these.

17. A higher premium will be awarded to the first and second places in the classes, and all the other birds will receive a set premium.

18. A copy of the proof of purchase with a clearly marked hatch date for meat pens must be presented at weigh-in. All birds used for meat pens must originate from a NPIP (National Poultry Improvement Plan) certified hatchery.

19. Birds must be bred by Fayette County Exhibitors and not be a recognized breed in the Standard of Perfection to be entered in the Home Cross-bred Class.

20. An interview by the judge about the birds value and history, and the condition of the specimen will be considered in awarding the placing in the Home Cross-bred Class.

21. Grooming time for washing poultry must be completed at least 2 hours before the start of the show.

3. All lambs must be in place by 7:00 AM on Monday of Fair Week. A mandatory barn meeting will be held prior to weigh-in.

4. All lambs will be weighed Monday of Fair Week immediately after the goats at 10:00 AM. No re-weighs are permitted. It is suggested that lambs be clean and shorn with no more than 1/4" of wool above the knees.

5. All members may tag in 5 lambs and show 3 head.

6. All sheep must have approved scrapie identification.

7. Lambs must weigh a minimum of 90 lbs. in order to be eligible for the Junior Fair Livestock Sale.

8. Lambs will be shown by breed. No registration papers are required. Classification of breed will be done at Monday's weigh-in.

ALL RECOGNIZED BREEDS in addition to Crossbred, natural colored, and white-face cross (brockle) are included and will be treated as breeds if the minimum of 5 head or 3 exhibitors is met.

9. All exhibitors will be given a card for each market lamb they are exhibiting. Exhibitors must fill out each card with his/her name, both Fayette County fair ear tag number and scrapie tag number, and the breed of his/her lamb. These cards are to be brought to the scales at the time of weigh-in to be processed for weight, breed and sales destination.

10. Classification will be done by three individuals evaluating lambs on the breed characteristics of each lamb using guidelines/criteria of breed associations. 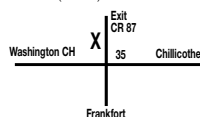

Crossbred Barrow and Gilt Classes:

1. Crossbred barrows and gilts will be classified as light and dark crosses by committee at weigh-in. The committee's decision is final.

2. A Champion and Reserve Champion will be selected for dark cross barrows, light cross barrows, dark cross gilts, and light cross gilts to participate in the Champion Drive for Overall Grand and Reserve Champion Market Hog.

The Market Hog Show order will consist of:

1. All purebred barrow classes (shown in alphabetical order), followed by dark cross barrows, light cross barrows, dark cross gilts, and light cross gilts.

2. Champion and Reserve Champion will be selected for each classification prior to starting weight classes for next classification

3. The five classification champions will show for Overall Market Hog Champion following the selection of the Light Cross Gilt Champion.

4. The Overall Reserve Champion market hog will be selected from the 4 remaining classification champions and the Reserve Champion from the Overall Grand

Champion's classification.

5. All remaining classification champions and Reserve champions will be used to select a 3rd, 4th, and 5th Overall market hog.

6. The Overall Grand and Reserve Championmarket hogs are terminal. Adhering to the Ohio Department of Agriculture and state laws.

7. Blood testing will occur if mandated by the state.

8. The Junior Fair officials Reserve the right to re-weigh the top 3-5 hogs at conclusion of each class. Hogs should not have a difference of 15 lbs. or more from the original weigh-in weight. Hogs differing more than 15 lbs. can be disqualified.

9. All Junior Fair swine project members are required to clean their pens out at the end of the week. Exhibitors not abiding by this rule will be charged a pen cleaning fee.

10. No shaving of hogs or excessive clipping permitted. No oil on hogs for show or the sale. Water only may be used for dressing on show and sale day.

Overall Champion Swine Showman. The top five Overall Showmen will then be selected from the remaining eight showmen in the final drive. Order of showmanship will be oldest to youngest.

LIVESTOCK SALE RULES

1. There shall be no other scales used in any of the livestock areas other than the official fair scales. Scales should not be brought on the fairgrounds. Anyone found in violation of weighing their market animals with other scales than the official scales at weigh-in will be disqualified from participation in the fair with that species of livestock.

2. EXHIBITORS ARE LIMITED TO SELLING 1 animal per project, with a maximum of two times through the sale ring. Example: 1 sheep and 1 hog, or 1 rabbit and 1 market beef. Only the Exhibitor who owns the animal may go through the sale ring unless special permission is granted by a Junior Fair Advisor ahead of the sale. This needs to be done ahead of time and the Sales Clerk notified.

3. All Champions and Reserve Champions must sell through the Junior Fair Livestock Sales and are terminal (Feeders are not terminal)

4. Any exhibitor winning 2 or more champions after selling a species through the sale that was a non-Champion will be required to forfeit the non-Champion money over market price.

5. Livestock sold through the Fayette County Junior Fair Sale are terminal and ineligible to be shown at any other Junior Fair Show including the Ohio State Fair.

6. Exhibitors have until 30 minutes following their respective show to tell the livestock sales committee which animal will sell, go home, or be placed on the truck to receive market price.

7. Any animal shown in an over/under weight class is not eligible to sell in the premium sell. These animals may be placed on the

truck to receive market price, or return home. The decision to sell or take the animal home must be made at weigh-in. The exception is market barrows, which must go to slaughter.

8. The order of the Small Animal Sale will be Rabbit, Chickens, Turkey, Meat Goats, and Dairy Goats. The sale order for the Friday Night sale will be Beef Feeders, Dairy Feeders, Steers, and Sheep.

SWINE

1. The sale will be held on Thursday evening at 5:30 PM. The swine committee will assume each exhibitor wants to sell his/her highest placing animal.

2. All Junior Fair exhibitors have the option of taking their animal home (unless it is Overall Grand or Reserve Champion), placing it on the truck to receive market price, or selling it through the ring.

3. The Junior Fair Swine Committee will allow all gilts going through the premium sale to be purchased out of the ring to be taken home. Whoever purchases the gilt must have a buyer's number prior to the start of the sale. The buyer must pay the premium bid and market price established by the packer at the conclusion of the sale.

SHEEP

1. The lamb sale will be held on Friday evening. The sale order will be determined by Overall placing of market lambs. All exhibitors with unsold lambs at the fair must dispose of the lambs on their own. These lambs will be released following the sale between the hours of 11:00 PM and 7:00 AM.

2. All exhibitors must be present and at their pens in the barns by at least 30 minutes before their sale time. If the exhibitor is not with lamb, it will not sell. Exhibitors or a family member must help load out their animal at the conclusion of the sale on Friday night. NO EXCEPTIONS

3. Exhibitors having lambs weighing less

than 90 lbs. forfeit their right to sell the lamb through the sale and show that lamb for Grand or Reserve Champion in the market lamb show.

4. Market ewe lambs are eligible to be purchased from the premium sale. They buyer must have a buyer's number prior to the start of the sale. They buyer must pay the premium bid and market price established by the packer at the conclusion of the sale.

CATTLE

1. The sale will be held on Friday evening.
2. Sale order will be determined by class placing.

3. All animals weighing 1000 lbs. or more are eligible for sale.

4. Those animals going home may be released following the sale during the hours of 11:00 PM and 7:00 AM.

GOATS

1. All market goats weighing 55 lbs. or more will be eligible to sell in the sale. The market goat sale will be held on Wednesday.

FEEDERS

1. Calves must weight 300 – 750 lbs. to sell. The sale will be Friday night. The feeder sale is not terminal. Any feeder may be purchased from the ring and taken home. The buyer will pay the premium bid and market price for the calf. Within 30 minutes of the conclusion of the Champion drive the exhibitor must inform the livestock sales committee of their sale intentions. The exhibitor may: take their calf home, place the calf on the truck for market price, place their calf in the premium sale and have the calf go on the truck for market price, or place the calf in the premium sale and have the calf go home. Calves going through the sale and going home will be identified on the sale bill as having no market price.

RABBITS

1. The sale will be on Wednesday. All meat pens of 2 rabbits must weigh between 3½ and 5 lbs. and under 69 days of age in order to sell in the Junior Fair Livestock Sale. Any rabbit weighing less than 3 ½ lbs. and over 5 lbs. disqualifies the pen from selling in the sale or competing for Champion or Reserve Champion.

CHICKENS

1. The sale will be held at on Wednesday. In order to sell the pen in the sale birds must individually weigh between 5 and 7 pounds.

TURKEYS

1. The sale will be held Wednesday. Turkeys must weigh between 30 and 45 pounds to sell.

SPECIAL RULES

1. Tampering and/or misrepresentation as to breeding, age, ownership and any other irregularity in showing will be considered fraud and deception. Any premiums, trophies, awards or sale money won by such exhibitor will be withheld.

2. Any artificial means of removing or remedying the physical defects or conformation in exhibition cattle, such as lifting and filling under the skin, use of sting, artificial heels, etc. will be considered fraud and deception. The use of an artificial tail head or altering the natural color of a steer animal shall be considered fraud and deception. All animals giving evidence of such treatment will be barred from competition at the Fayette County Fair.

3. Should fraud or deception be discovered after the animal or animals have been shown and prior to the sale, such animal(s) shall not be permitted to sell. The animals placing next in line at the show shall move up.

4. Should violation be discovered after the sale, all sale money shall be returned to the buyer and the animal or carcass shall be returned to the exhibitor. In all livestock and poultry classes, these regulations will be in full force and effect.

mine if a substance has been administered to the animal to change the conformation or temperament of the animal.

RULE VIOLATIONS

1. In the question of a rule violation, the following due process will be used. The exhibitor and/or parties involved will be questioned by Fair Officials in that particular department, and will make recommendations to the Fair Board.

2. In the decision of a case being brought before the Board all parties involved will be notified of a hearing date with all parties having the right to present their case.

3. Upon hearing the case, the Fayette County Fair Board will make a ruling.

4. When satisfactory evidence has been obtained by the Fair Board that any of the livestock rules have been violated, the exhibitor and/or exhibitor's family may be barred from showing in any future Fairs. The minimum number of years for the barment is three (3) years before the right to a review. In case any premium shall have been awarded to animals shown in violation of this rule, the Fayette County Senior Fair Board will request the exhibitor to refund all premiums, trophies, ribbons and sale money under such violation.

TESTING FOR DRUGS

1. The Fayette Co. Fair Board shall have the right to require place 1 through 5 in each class of animals, or any other suspected animal, to be subject to random examinations or tests as prescribed by the Board to deter-
