

**Fayette County Junior Fair  
2013 Queen Contest**

**Qualifications & Requirements for Entry:**

- Contestants must be high school seniors or high school graduates no older than 19 years of age as of January 1, 2013.
- Must be currently active in any one of the following Fayette County youth organizations:

4-H	Campfire	FCCLA
FFA	Girl Scouts	Junior Achievement
Farm Bureau Youth	Future Homemakers of America	
- Contestant must be single and not have parented any children.
- Previous members of the court are permitted to apply, but previous Queens are not.
- Current year commodity queens are ineligible – cannot hold two crowns at once.
- Contestants must conduct themselves in accordance with the standard of behavior set forth by the Fayette County Junior Fair Board throughout the application process and any subsequent reign.
- Applications must be postmarked or hand delivered no later than 4:30 PM May 25, 2013.
- NO LATE, INCOMPLETE OR HANDWRITTEN APPLICATIONS WILL BE ACCEPTED.
- Contestants must attend the Candidates Reception on Tuesday July 2, 2013
- The 2013 Fayette County Fair Queen must compete in the 2014 Ohio Fair Manager’s Queen Contest to be held in January 2014 at the Ohio Fair Manager’s Conference in Columbus, Ohio.

**Application Requirements:**

- Applicants must complete the 2013 Fayette County Junior Fair Queen Contest Application which includes the following:
  1. Applicant’s Information
  2. First page of the application must be signed by the applicant’s parent/guardian and club/organization advisor.
  3. Resume of the applicant’s Junior Fair accomplishments (not to exceed two single-sided typed pages) detailing participation, honors and service.
  4. Written statements (not to exceed one single-sided typed page in it’s entirety) to answer the essay questions.
  5. Photograph page (not to exceed one page 8 ½ x 11) representing your Junior Fair involvement.
  6. A summary page with photograph for release to the media.
  7. The signed Fayette County Junior Fair Queen Contract.

- A minimum of two attendants and one queen will be selected by the judges. Only the finalists will be announced at the Candidates Reception. The queen will be crowned at the Opening Ceremonies of the 2013 Fayette County Fair. All finalists are expected to attend the opening ceremonies.
- The judges’ decision is final.

- Leadership: List all activities you have performed to benefit and strengthen the Junior Fair program. Include promotion, recruitment, public speaking, offices, committees, education and communication experiences.
- School Activities: List your past activities, honors and awards.

Do not exceed one typed page in its entirety. Write a short statement for each of the following questions:

1. Why do you want to be the 2013 Fayette County Fair Junior Fair Queen?
2. What do you consider to be the most important role of the Junior Fair Queen?
3. What has been your favorite personal Junior Fair Experience?
4. What suggestions do you have for expanding or improving the Fayette County Junior Fair?
5. What are your personal goals for the future?

### **Section V - Photograph Page:**

Do not exceed one page (8 ½ x 11). You may use any type of paper so long as you do not exceed the size limit. Please compile a page of photographs of your organization events, activities, projects and/or experiences. Use your creativity to bring these experiences to life.

### **Section VI - Summary Page:**

Include a summary of you and your activities using one single-spaced type written page not to exceed 250 words. Enclose a recent photograph (preferably a head and shoulders shot) to be used in various media publications. All summaries and photos will be submitted to the media exactly as they are received.

### **Section VII - Signed Royalty Contract:**

Print or type your name at the top of the attached Fayette County Fair Junior Royalty Contract, sign and date at the bottom. This form must be included with your application.

## FAYETTE COUNTY JUNIOR FAIR ROYALTY CONTRACT

I, \_\_\_\_\_ will abide by all rules and regulation of the Fayette County Junior Fair and The Fayette County Agricultural Society. I understand that I am representing the members fo the Fayette County Junior Fair organization and that it is my responsibility to be a good role model and act appropriately throughout the year. I will fulfill my junior fair royalty responsibilities as outlined in the application and by the Junior Fair Royalty Coordinators. **I understand that I will be present 100% at the Fayette County Junior Fair and at all required Junior Fair activities.** I will fulfill all Junior Fair duties assigned to me during the course of my reign as a member of the court. I agree to attend all Junior Fair events as assigned by the Junior Fair Royalty Coordinators. If selected as the fair queen, I agree that I will compete in the Ohio Fair Manager's Queens Contest in January, 2014, unless extreme circumstances prevent me from doing so.

As a Royalty Court Member, I will attend all events with a positive and enthusiastic attitude. I will dress appropriately during the entire fair as outlined by the Junior Fair Royalty Coordinators. I understand that the following garments are not appropriate: short skirts, low tops, midriffis or inappropriate t-shirts with designs/logos. I further understand that if dressed inappropriately, I will be asked to change my clothes and may not be included in buyer pictures or recognized at that particular event. If asked twice to change clothes, I will give up my crown and sash to the Junior Fair Coordinator and the 4-H Youth Development Extension Educator immediately.

I agree to wear my Junior Fair wristband at all times when on the Fayette County Fairgrounds. If I do not have my wristband on, I will be asked to leave the fairgrounds to get a new wristband at a cost of \$25. I will not be permitted to take part in pictures or award ceremonies without a wristband. If told twice, I will have my title, crown and sash revoked immediately.

The following is a list of offenses, whether they occur on or off the fairgrounds, that would result in me immediately relinquishing my crown, sash, title and all responsibilities and honors associated with the Fayette County Junior Fair Queen or the Court:

- Possession of alcohol, tobacco products or illegal drugs.
- Being intoxicated or drinking underage.
- Violating a Junior Fair rule as stated in the current Fayette County Junior Fair Rule Book.

I understand that being selected to serve as a member of the Fayette County Junior Fair Royalty Court is an honor. I will act with dignity and respect worthy of a member of the court. If at any time, I do not abide by these rules and standards, I will forfeit my right to serve as a Court member of the Fayette County Junior Fair. Also, if I must relinquish my Junior Fair Court membership at any time for any reasons as stated above, I will also give up the right to participate in the Ohio Fair Manager's Queen Contest at the Ohio Fair Manager's Conference in January following the Fayette County Fair.
